SIXTH STATUS REPORT

Pursuant to the orders of the Illinois Pollution Control Board ("Board") dated April 18, August 22 and October 3, 2013, Respondent, The Board of Trustees of the University of Illinois ("University"), by its attorneys, hereby provides this Sixth Status Report.

- 1. The Board's orders, referenced above, granted a stay of this matter which expires October 10, 2013 and required the parties to file status reports every 30 days.
- 2. The University initiated suit against the People of the State of Illinois ("State") in the Circuit Court of Cook County, *The Board of Trustees of the University of Illinois v. Illinois Environmental Protection Agency, et al.*, No. 13-CH-162, seeking a declaratory judgment that jurisdiction over the State's claims against the University rests solely with the Illinois Court of Claims.
- 3. Since the last status report filed with the Board on September 20, 2013, Judge Sophia H. Hall of the Circuit Court of Cook County issued a ruling on the parties' respective motions for judgment on the pleadings.
- 4. On October 4, 2013, Judge Hall granted the State's Motion for Judgment on the Pleadings and denied the University's Cross-Motion for Judgment on the Pleadings.
