RECOMMENDATION

NOW COMES the ILLINOIS ENVIRONMENTAL PROTECTION AGENCY ("Illinois EPA"), through its attorneys, and pursuant to 35 Ill. Adm. Code 125.204 of the ILLINOIS POLLUTION CONTROL BOARD'S ("Board") procedural regulations, files the Illinois EPA's Recommendation in the above-referenced request for tax certification of pollution control facilities. The Illinois EPA recommends **issuance** of a tax certification covering the subject matter of the request. In support thereof, the Illinois EPA states as follows:

- 1. On or about March 8, 2012, the Illinois EPA received an application and supporting information from ENBRIDGE PIPELINES, LLC, ("Enbridge Pipelines") concerning the proposed tax certification of certain air emission sources and/or equipment located at its Village of Manhattan petroleum storage facility in Will County, Illinois. A copy of the application is attached hereto. [Exhibit A].

- 4. The subject matter of this request involves the construction and installation of an Internal Floating Roof system on a petroleum liquid storage tank identified as Tank No. 1 at the Manhattan storage facility. As described in the application, the roofing system constructed and installed on the subject storage tank "rises and falls with the liquid level [of the storage tank] to reduce the vapor space inside the tank." *See*, Application at page 1, Section D. By doing so, the system acts to prevent or reduce volatile organic materials ("VOM") emissions that would otherwise be emitted from the tank to the atmosphere.
- 5. Section 11-10 of the Property Tax Code, 35 ILCS 200/11-10 (2002), defines "pollution control facilities" as:

"any system, method, construction, device or appliance appurtenant thereto, or any portion of any building or equipment, that is designed, constructed, installed or operated for the primary purpose of: (a) eliminating, preventing, or reducing air or water pollution... or (b) treating, pretreating, modifying or disposing of any potential solid, liquid, gaseous pollutant which if released without treatment, pretreatment, modification or disposal might be harmful, detrimental or offensive to human, plant or animal life, or to property."

- 6. Pollution control facilities are entitled to preferential tax treatment, as provided by 35 ILCS 200/11-5 (2002).
- 7. Based on information in the application and the underlying purpose of the Internal Floating Roof system for Tank No. 1 to prevent, eliminate or reduce air pollution, it is the Illinois EPA's engineering judgment that the system may be considered as "pollution control facilities" in accordance with the statutory definition and consistent with the Board's regulations at 35 Ill. Adm. Code 125.200. [Exhibit B]. In keeping with prior recommendations in similar matters,

the Illinois EPA would expect any preferential tax treatment, as determined by the Department of Revenue in separate proceedings, to address only the incremental costs associated with the Internal Floating Roof system in relation to conventional fixed roof systems.

8. Because the applicant's request for the Internal Floating Roof system for Tank No. 1 satisfies the aforementioned statutory and regulatory criteria, the Illinois EPA recommends that the Board issue a tax certification for the same.

This Agency received a request on March 08, 2012 from Enbridge Pipelines (Southern Lights), L.L.C. for an Illinois EPA recommendation regarding tax certification of air pollution control facilities pursuant to 35 Ill. Adm. Code 125.204. I offer the following recommendation.

The air pollution control facilities in this request include the following:

Tank #1 Internal Floating Roof which reduces Volatile Organic Compound(VOC)emissions by protecting and retaining petroleum products at the facility. Because the primary purpose of this system is to reduce or eliminate air pollution, it is certified as a pollution control facility.

This facility is located at 15637 West Bruns Road, Manhattan, Illinois, Will County
The property identification number is 12-29-101-002-0000

Based on the information included in this submittal, it is my engineering Judgement that the proposed facility may be considered "Pollution Control Facilities" under 35 IAC 125.200(a), with the primary purpose of eliminating, preventing, or reducing air pollution, or as otherwise provided in this section, and therefore eligible for tax certification from the Illinois Pollution Control Board. Therefore, it is my recommendation that the Board issue the requested tax Certification for this facility.
