#### ANSWER TO COMPLAINT

- The Respondent admits the allegation of Paragraph 1 of the Complaint that Maurice Whisenhunt resides at 16147 E. Saddle Club Road, Bonnie, Illinois.
- 2. The Respondent has no knowledge as to where Maurice Whisenhunt works and therefore neither admits nor denies the allegations in Paragraph 2 of the Complaint.
