AmerenEnergy Resources Generating Company ("Petitioner" or "AERG"), by and through its attorneys, SCHIFF HARDIN LLP, pursuant to 35 Ill. Admin. Code 101.308(c)(2), hereby agrees to a limited waiver of the statutory 120-day decision deadline for final action by the Illinois Pollution Control Board ("Board") in this proceeding until May 15, 2014. In support of this waiver, Petitioner states as follows:

1. On November 27, 2013, Petitioner filed a petition for review of the default disapproval, by failure to take action, of AERG's request for beneficial use determination ("BUD"), pursuant to Section 3.135(b) of the Illinois Environmental Protection Act (the "Act") and 40 of the Act (415 ILCS 5/3.135(b) and 5/40) ("Petition for Review").
