HEARING OFFICER ORDER

On January 23, 2014, all parties participated in a telephonic status conference with the hearing officer. The complainant stated that it has recently received respondent's comments and suggested revisions to the draft stipulation and proposal for settlement (stipulation). The complainant has forwarded the stipulation to the Illinois Environmental Protection Agency for its review.

By agreement, the respondent's answer or other pleading is now due to be filed on or before April 11, 2014.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on March 13, 2014, at 10:30 a.m. The telephonic conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing. If, however, a stipulation is filed prior to the next status conference, the conference will be cancelled without further notice.
