## STATUS FOR SUBDOCKET D

The Illinois Environmental Protection Agency ("Illinois EPA" or "Agency"), by and through its attorneys, hereby submits a status as requested by the hearing officer at the December 17, 2013 hearing. The Agency states as follows:

1) On October 26, 2007, the Agency filed a rulemaking proposal to update the

designated uses and accompanying water quality standards for the waters currently designated for Secondary Contact and Indigenous Aquatic Life Use which includes most waters in the Chicago Area Waterway System ("CAWS") and Lower Des Plaines River.

2) On November 1, 2007, the Board accepted the Agency's proposal for

hearing.

3) On March 18, 2010, the Board issued an order dividing R08-09 into four separate subdockets. Pursuant to the Board's March 18, 2010 Opinion and Order, Subdocket D was "created to address the issues dealing with water quality standards

and criteria, which are necessary to meet the aquatic life use designations." <u>See</u>, Opinion, P. 1.

4) At the end of the December 17, 2013, the hearing officer asked the participants in the rulemaking to give a status as to whether the participants needed more time to discuss Subdocket D issues or if the participants where ready for the hearing officer to set a post hearing comment deadline. <u>See</u>, Hearing transcript P. 202.

5) The Agency is ready to proceed to post hearing comments for all the standards proposed in Subdocket D except for the chloride standard. The Agency is still in discussions with various parties, as well as, with the USEPA with respect to chlorides. It is clear that more time is needed to work on an approvable chloride standard and what would be needed to obtain a variance, as discussed at the last hearing.

6) Therefore, the Agency proposes that a new subdocket be reserved for the issue of chlorides. By granting a separate subdocket for chlorides, it will allow the various participants the necessary time to address the issues without delaying the other standards from moving forward. The Agency encourages the Board to move forward with setting a post hearing comment deadline with respect to all the other standards addressed in Subdocket D.
