HEARING OFFICER ORDER

On April 8, 2014, all parties participated in a telephonic status conference with the hearing officer. Although not discussed during the conference call, the petitioner is encouraged to file an expedited response so that the Board can decide in a timely manner.

The respondent further stated that it anticipates filing a response to petitioner's motion for protective order regarding respondent's witness disclosure, filed April 8, 2014. The respondent stated that it intends to file its expedited response on or before April 11, 2014.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on April 14, 2014, at 12:30 p.m. The telephonic conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.


