### RESPONDENT'S MOTION TO HEARING OFFICER TO CLARIFY RESPONDENT'S POSITION ON FILING OF INTERLOCUTORY APPEAL AND RESPONSE TO KCBX MOTIONS FOR PROTECTIVE ORDER AND TO SUPPLEMENT

1. On April 9, 2014, the Hearing Officer issued his Order in follow up of the status conference held on April 8, 2014. Respondent now seeks to clarify its position on the filing of an interlocutory appeal of the Hearing Officer's April 8, 2014 Order.

 Respondent acknowledges that it advised the Hearing Officer that it would attempt to file this Appeal by April 11, and also intended to file its response to Petitioner's April 8, 2014 Motion for Protective Order as soon as reasonably possible. Petitioner will also respond to Petitioner's April 9, 2014 Motion to Supplement the Record as quickly as possible.

3. Assistant Attorneys General Kathryn Pamenter and Christopher Grant are presently assigned to this case. On the date the Hearing Officer entered his decision, April 8, 2014, AAG Grant was at Illinois EPA's offices in Springfield, Illinois, preparing for depositions on April 9. On April 9, both Pamenter and Grant were presenting witnesses at opposing counsel's office in Springfield. On April 10, 2014, a third deposition was taken by Petitioner, also at counsel's office in Springfield. On April 11, Petitioner's counsel took the deposition of a fourth Illinois EPA witness in Chicago. Depositions are now scheduled for April 14 and 15 in Chicago, and April 16 in Springfield (2 depositions).

4. In addition to the above, the undersigned will be in Court in Kane County on April 14th, and a hearing in Kankakee County April 18th. Respondent is currently seeking to have a third attorney assigned to the case to assist with the overwhelming amount of work necessitated by the abbreviated schedule.

5. Respondent will attempt to file its Interlocutory Appeal on April 14, 2014, and its responses to the other two Motions as soon as reasonably possible. Respondent believes that it is entitled to prepare and present the best case possible, and that the Board is entitled to a thorough examination of the issues in these filings. Respondent notes that the Board has acknowledged that in cases where a Petitioner refuses to extend the statutory review deadline, the Board must balance the rights of the Petitioner to an expedited hearing with the interests of the public for a fair review of the issues must be taken into consideration. *Joliet Sand & Gravel Company v. Illinois EPA*, PCB 86-159 (December 23, 1986).
