**HEARING OFFICER ORDER**

On April 29, 2014, the parties participated in a telephone status conference with the hearing officer. Pursuant to the terms of the parties' settlement agreement, respondent Peabody Gateway North Mining LLC (Peabody) is required to apply for a revised permit modification with the Agency no later than June 9, 2014. Petitioners will dismiss this appeal within 15 days of Peabody's application.

The parties are directed to participate in a telephone status conference with the hearing officer at 11:00 a.m. on July 1, 2014 if the petitioners have not moved to dismiss this appeal before that date.

The decision deadline is currently August 21, 2014. Peabody agreed to file an additional deadline waiver.
