AGENCY'S RESPONSE TO THE ILLINOIS POLLUTION CONTROL BOARD'S QUESTION PURSUANT TO THE MARCH 18, 2014 HEARING OFFICER ORDER

NOW COMES the Illinois Environmental Protection Agency ("Illinois EPA" or "Agency") by one of its attorneys, Sara Terranova, and pursuant to the March 18, 2014 Hearing Officer Order, hereby responds to the Illinois Pollution Control Board's (Board) Question. The Agency states as follow:

PCB 09-125 Condition 2

This condition directs the Agency to modify the District's NPDES permit consistent with the PCB 09-125 variance. According to the District's most recent Interim Report dated December 20, 2013, the Agency has not yet modified the District's NPDES permit. Exh. I at 1. Please provide an update regarding the status of Decatur's NPDES permit modification to incorporate the variance in PCB 09-125.

The Board issued the initial variance with conditions in PCB 09-125 on January 7, 2010, directing the Agency to modify the District's NPDES permit consistent with the Order. That NPDES permit expired on June 30, 2012. The Agency received a timely renewal request from the District on December 27, 2011. Therefore, pursuant to 35 Ill Adm. Code 309.104(a), the District's NPDES permit is presently administratively continued. The Agency is currently in the process of renewing the District's NPDES permit and intends to include all applicable provisions of the Board's PCB 09-125 Order in the draft permit. Pursuant to 35 Ill Adm. Code 309.104(b), as part of the renewal process, the Agency will circulate public notice of the draft permit. Finally, as the Board is aware, pursuant to 40

CFR 123.44 the permit is subject to U.S. EPA review and approval.

The Illinois EPA is aware the District filed a Motion to Stay the Proceeding on April 21, 2014. While the Agency has no objection to the Motion to Stay the Proceeding, the Agency is also cognizant the Board has yet to rule on this matter. Therefore, in accordance with the deadline established in the March 18, 2014 Hearing Officer Order, the Agency is responding to the Board's question as directed.

WHEREFORE, the Illinois Environmental Protection Agency submits the above Response to the Illinois Pollution Control Board's Question pursuant to the March 18, 2014 Hearing Officer Order.
