

**HEARING OFFICER ORDER**

On July 10, 2014, all parties participated in a telephonic status conference with the hearing officer. It is noted that the respondent has filed a complaint for allocation and proportionate share of responsibility with the Board, docket number PCB 14-81.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on September 25, 2014, at 9:30 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for their own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


