
**HEARING OFFICER ORDER**

On July 10, 2014, all parties participated in a telephonic status conference with the hearing officer. The respondent stated that since the last status conference, it has had a meeting with the United States Environmental Protection Agency (USEPA) regarding petitioners' comments. The respondent stated that there appears to be a few issues regarding the comments and that a meeting is scheduled for July 15, 2014, with the petitioners, respondent and the USEPA to discuss what exactly the issues are and how to possibly resolve them.

The petitioners stated that they will file an additional waiver of the statutory decision deadline to and including December 18, 2014.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on August 14, 2014, at 11:00 a.m. The telephonic status conference must be initiated by the petitioners, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


