NOTICE OF INTENT TO FILE A RESPONSE IN OPPOSITION TO PETITIONER'S MOTION TO STAY

Now comes Respondent, ILLINOIS ENVIRONMENTAL PROTECTION AGENCY ("IEPA"), by LISA MADIGAN, Attorney General of the State of Illinois, and hereby gives notice of its intent to respond to Petitioner's, CLINTON LANDFILL, INC. ("CLI"), Motion to Stay. In support of this filing, the IEPA states as follows:

- 1. On August 28, 2014, CLI filed its Petition for Review of Permit ("Petition") and Motion for Order Regarding Stay ("Motion to Stay") with the Illinois Pollution Control Board ("Board").
 - 2. On September 2, 2014, the IEPA received CLI's Petition and Motion to Stay.
- 3. On September 2, 2014, the Illinois Attorney General's Office received the IEPA's request for representation in the above-captioned matter.
- 4. Pursuant to Section 101.500(d) of the Board Procedural Rules, 35 Ill. Adm. Code 101.500(d), a party may file a response to a motion within 14 days after service of the motion. Therefore, Respondent's response to the Motion to Stay is due by September 16, 2014.
