




MOTION FOR VOLUNTARY DISMISSAL

NOW COMES Petitioner Kramer Tree Specialists, Inc. (“Kramer”) by its attorneys, to move the Illinois Pollution Control Board (the “Board”) to dismiss the above-captioned permit appeal.

Kramer moves to voluntarily dismiss this pending permit appeal because the appeal has been mooted by the Board’s August 21, 2014 Opinion and Order in the matter of *Petition of Kramer Tree Specialists, Inc. for an Adjusted Standard from 35 Ill. Adm. Code 830*, (AS 14-2) (the “Opinion”). This permit appeal challenges the Illinois Environmental Protection Agency’s denial of Kramer’s application for a permit pursuant to Part 830 of the Illinois Administrative Code filed by Kramer in relation to its mulching operation. In the Opinion, however, the Board found “that Part 830 of the Board’s standards for compost facilities do[] not apply to Kramer’s mulching operation” As such, the Board has determined that no permit under Part 830 is necessary or appropriate with respect to Kramer’s mulching operation.

ACCORDINGLY, Kramer requests that the Board dismiss the above-captioned matter as moot.
