

MOTION FOR LEAVE TO FILE REDUCED NUMBER OF COPIES OF RECORD

NOW COMES Respondent, ILLINOIS ENVIRONMENTAL PROTECTION AGENCY, by Lisa Madigan, Attorney General of the State of Illinois, and moves for leave to file a reduced number of copies of the record of decision for the subject permit. In support thereof, Respondent states as follows:

1. Section 101.302(h) of the Board's Procedural Rules, 35 Ill. Adm. Code 101.302 (h), provides that the Illinois EPA is to file an original and 9 duplicate copies of the record.

2. The record in this matter consists of 1,559 pages. Due to technology system constraints, electronic filing of the record is not reasonably possible. Duplication of 9 copies of the record would be both time consuming and a strain on State resources. Respondent requests the Board's consideration of a reduction in the number of copies required.

3. Respondent requests that the Board accept original and 2 copies of the record in this matter, along with a complete CD copy. Respondent will serve a CD copy of the record of decision on Petitioner.


WHEREFORE, on the foregoing grounds and for the foregoing reasons, Respondent respectfully requests leave to file a reduced number of copies, including an original, two paper


