NOTICE OF LIMITED WAIVER OF 120-DAY DECISION DEADLINE

NOW COMES Petitioner, UNITED STATES STEEL CORPORATION (“Petitioner”), by and through its attorneys, HODGE DWYER & DRIVER, pursuant to 35 Ill. Admin. Code § 101.308(c)(2), hereby agrees to a limited waiver of the statutory 120-day decision deadline for final action by the Illinois Pollution Control Board (“Board”) in this proceeding until April 30, 2016. In support of this Notice, Petitioner states as follows:

1. On May 6, 2013, Petitioner filed a Petition for Review (“Petition”) of the Construction Permit with Integrated Processing issued to Petitioner by the Illinois Environmental Protection Agency (“Illinois EPA”) on April 1, 2013, for an emission control system for Petitioner’s basic oxygen process (“BOP”) furnaces at Petitioner’s integrated steel mill plant located in Granite City, Illinois.

2. On May 16, 2013, the Board accepted Petitioner’s Petition for hearing. Board Order, *United States Steel Corporation v. Illinois EPA*, PCB No. 13-62 (Ill.Pol.Control.Bd. May 16, 2013).

3. The current decision deadline for this matter is June 1, 2015.

4. Petitioner hereby voluntarily agrees to a limited waiver of the statutory 120-day decision deadline until April 30, 2016.

WHEREFORE, Petitioner, UNITED STATES STEEL CORPORATION, prays that the Illinois Pollution Control Board accept this limited waiver of the statutory 120-day decision deadline for final action on Petitioner's Petition for Review.
