**MOTION FOR EXTENSION OF TIME TO FILE ADMINISTRATIVE RECORD**

NOW COMES the Respondent, ILLINOIS ENVIRONMENTAL PROTECTION AGENCY (“Illinois EPA”), by and through its counsel, Special Assistant Attorney General Scott B. Sievers, and, pursuant to 35 Ill. Adm. Code 101.522, moves this honorable Board for a two (2) day extension of time to file the administrative record in this action. In support, the Respondent states the following:

1. Section 101.522 of the Board rules provides that “[t]he Board or hearing officer, for good cause shown on a motion after notice to the opposite party, may extend the time for filing any document or doing any act which is required by these rules to be done within a limited period, either before or after the expiration of time.” 35 Ill. Adm. Code 101.522.

2. The administrative record in the instant case presently is due to be filed by January 20, 2015. *See, e.g.*, Order at 2 (Jan. 8, 2015); 35 Ill. Adm. Code 105.116.

3. The Respondent has determined that the administrative record in the instant action comprises at least 484 pages. As such, printing off the requisite multiple copies, burning compact discs/digital video discs, or CDs/DVDs, and preparing the same for service by mailing and for filing has proven more time-consuming than anticipated.

4. Consequently, to allow sufficient time to complete preparation of the administrative record for service by mailing and for filing, the Respondent seeks a two (2) day extension of time to file the administrative record in this action.

WHEREFORE, the Respondent, ILLINOIS ENVIRONMENTAL PROTECTION AGENCY, prays that this honorable Board ALLOW the instant Motion for Extension of Time to File Administrative Record and extend the time for the Respondent to file the administrative record by two (2) days, from January 20 to January 22, 2015.
