HEARING OFFICER ORDER

On February 2, 2015, the parties participated in a telephone status conference with the hearing officer. The Illinois Environmental Protection Agency approved a remediation plan that requires a project labor agreement (PLA). Because there are no administrative rules for PLAs, respondents' consultant is unsure about how to implement this requirement, and expects the bidding process to take several months. The parties will review the Board's order in Allen McAfee v. IEPA (PCB 15-84) to determine whether the outcome may be relevant to this case.

The parties are directed to participate in a telephone status conference with the hearing officer at 10:30 a.m. on March 18, 2015. The People will circulate a conference call-in number.
