**HEARING OFFICER ORDER**

On March 18, 2015, the People and respondents Six M. Corporation and William Maxwell participated in a telephone status conference with the hearing officer. Respondent McIlvaine did not appear. In light of the Board's ruling in Allen McAfee v. IEPA (PCB 15-84, Mar. 5, 2015), respondents will resubmit the application for the proposed site investigation plan to the Illinois Environmental Protection Agency. The Agency is expected to approve the plan without requiring a Project Labor Agreement. Once the plan is approved, site investigation activities will resume.

The parties are directed to participate in a telephone status conference with the hearing officer at 10:00 a.m. on May 18, 2015. The People will circulate a conference call-in number.
