MOTION FOR EXTENSION OF TIME TO FILE ADMINISTRATIVE RECORD

NOW COMES the Respondent, ILLINOIS ENVIRONMENTAL PROTECTION AGENCY, by and through its attorney, Special Assistant Attorney General Scott B. Sievers, and, pursuant to 35 Ill. Adm. Code 105.116(a), moves for a three (3) day extension of time within which to file the administrative record in this action. In support, the Respondent states the following:

1. On April 2, 2015, this honorable Board ordered the Respondent to "file the entire record of its determination by May 4, 2015, which is the first business day following 30 days after the Board received petitioner's petition."

3.
