
HEARING OFFICER ORDER

On May 21, 2015, all parties participated in a telephonic status conference with the hearing officer. By agreement, the record in the above-captioned matter is now due to be filed on or before June 29, 2015. Midwest Generation, LLC., stated that it will file waiver of the statutory decision deadline to and including November 5, 2015.

At this time, the parties anticipate filing dispositive motions after the review of the record. Further discussion will be entertained at the next status conference.


