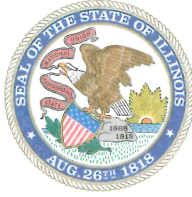

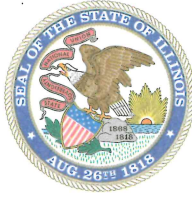

**Agency:** Pollution Control Board

**Rulemaking:** Water Quality Standards (35 Ill. Adm. Code 302; 38 Ill. Reg. 19366)

### Changes:

1. In line 371, after "Chicago River" add a comma.
2. In line 380, after "standards" add a comma.
3. In the table after line 525, in the rows for "Fluoride (total)" and "Manganese (dissolved)", remove italics from " $A+B \ln(H)$ " in the 2<sup>nd</sup> and 3<sup>rd</sup> columns.
4. In lines 546-547, change "the effective date of this rule until three years after the effective date" to "July 1, 2015 until July 1, 2018".
5. In the tables after lines 550 and 557, insert the following heading row:

6. In line 552, change "From three years after the effective date of these rules" to "Beginning July 1, 2018" and capitalize "chloride".
7. In line 553, capitalize "section".
8. In the formula after line 560, after "liter" delete the period.
9. In the table after line 565, first row, strike "CONSTITUENTS" and add "CONSTITUENT".
10. In line 588, after "(i)" delete the comma.
11. Change line 589 to "beginning July 1, 2018. Starting July 1, 2015".
12. In line 590, delete "from the effective date of this Section".
13. In line 600, change "which" to "that".
14. In line 606, after "temperature" add "at representative locations in the main river".

15. In line 643, change "Part" to "35 Ill. Adm. Code" and change "substance" to "substances".
16. In lines 711-714, change the all capitalized text to mixed case.
17. In line 714, change "(a)" to "(f)(1)".

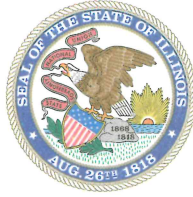

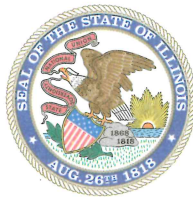
