
HEARING OFFICER ORDER

The hearing officer acknowledges that on June 12, 2015, complainants filed an “Agreed Motion for Entry of Stipulation and Order on Expert Discovery”. (Motion) Attached to the Motion is a “Stipulation And Order On Expert Discovery”. (Stipulation)

In pertinent part, the Stipulation states that “[t]he parties agree that, notwithstanding any Interrogatories or Requests for Production already propounded in this action, Draft Reports created by any testifying experts in this action are protected from discovery, unless the party seeking discovery shows substantial need and obtains an Order from the Hearing Officer”. Stipulation at 1.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on September 10, 2015, at 11:30 a.m. The telephonic conference must be initiated by the complainants, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.
