NOTICE OF WAIVER OF 120-DAY DECISION DEADLINE

NOW COMES Petitioner, FLINT HILLS RESOURCES JOLIET, LLC (“Petitioner”), by and through its attorneys, HODGE DWYER & DRIVER, pursuant to 35 Ill. Admin. Code § 101.308(c)(2), and hereby waives the statutory 120-day decision deadline for final action by the Illinois Pollution Control Board (“Board”) in this proceeding until February 18, 2016. In support of this Notice, Petitioner states as follows:

1. On July 21, 2015, Petitioner filed its Petition for Variance (“Petition”) requesting a variance from the deadline for complying with temperature standards at 35 Ill. Admin. Code §§ 302.408(b), (c), (d), (e), (f), and (i) for its Channahon Facility pursuant to the terms and conditions outlined in its Petition.
2. On August 6, 2015, the Board accepted the Petition.
3. The current statutory decision deadline for this matter is November 18, 2015.
4. Petitioner hereby voluntarily agrees to waive the statutory 120-day decision deadline until February 18, 2016.

WHEREFORE, Petitioner, FLINT HILLS RESOURCES JOLIET, LLC, prays that the Illinois Pollution Control Board accept this waiver of the statutory 120-day decision deadline for final action on Petitioner's Petition for Variance.
