**TIME CERTAIN WAIVER**

NOW COMES the Village of Richton Park, by its attorneys, Rosenthal, Murphey, Coblentz & Donahue, and pursuant to Part 101.308 of Title 35 of the Illinois Administrative Code, 35 Ill. Admin. Code § 101.308, hereby petitions the Illinois Pollution Control Board ("Board") for a Time Certain Waiver as follows:


1. On July 22, 2015, the Village of Richton Park filed a petition pursuant 415 ILCS 5/35 (a) and 35 Ill. Admin Code § 104.100 to for a variance authorizing discharges from its storm sewers and outfalls into the Cook County Area Waterways System pursuant to the terms and conditions outlined in the Petition for Variance ("Petition").
1. Pursuant to 35 Ill. Admin Code § 101.308(a), a Petition for Variance has a 120 statutory decision deadline.
2. Pursuant to 35 Ill. Admin Code § 101.308(c), a party can file a waiver of the Statutory deadline.
3. The Village of Richton Park requests a waiver of the statutory decision deadline up to and including February 16, 2016.

WHEREFORE, the Village of Richton Park respectfully requests a time specific waiver of the statutory deadline up to and including February 16, 2015.
