**HEARING OFFICER ORDER**


On October 21, 2015, all parties participated in a telephonic status conference with the hearing officer. Parties from the related case of PCB 16-56 also appeared.

The parties are discussing the possibility of filing a motion to consolidate this matter with the related PCB 16-56 matter. By agreement, the Village of Rockdale's record is now due to be filed on or before November 23, 2015. Also by agreement, the parties will submit a proposed discovery schedule on or before October 29, 2015.

Finally, respondent Environmental Recycling and Disposal Services Inc. stated that it will file an additional waiver of the statutory decision deadline to and including March 18, 2016.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on November 4, 2015, at 1:00 p.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.
