
HEARING OFFICER ORDER

The petitioner stated that it will file an additional waiver of the statutory decision deadline to and including April 7, 2016.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on December 17, 2015, at 9:30 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




