

RESPONDENT'S MOTION FOR ADDITIONAL TIME TO FILE RESPONSE

Now comes Respondent, the ILLINOIS ENVIRONMENTAL PROTECTION AGENCY, through its attorney LISA MADIGAN, Attorney General of the State, and requests that the Hearing Officer grant it an additional extension, until December 1, 2015, to file its Response to Petitioner's Motion for Summary Judgment. In support thereof, Respondent states as follows:

1. Petitioner filed its Motion for Summary Judgment in this matter on October 21, 2015. On November 5, 2015, the Hearing Officer granted Respondent's Motion to extend the date for filing its Response to Petitioner's Motion to November 20, 2015.
2. Assistant Attorney General Nancy Tikalsky is the lead attorney for Respondent in this matter. On November 14, 2015, a close family member of Ms. Tikalsky passed away unexpectedly. As of the date of filing this Motion, Ms. Tikalsky is out-of-state to attend the funeral, and to assist in family business related to the death of the family member. Ms. Tikalsky, who has drafted all documents filed in this matter by the Respondent, is not expected back in time to complete the Response by the current filing deadline.
3. On November 16, 2015, the undersigned contacted Mr. Edward Walsh, counsel for Petitioner, to request an extension of the Response deadline until December 1, 2015. Mr.


Walsh has graciously agreed to the extension.

4. This matter is set for status on November 24, 2015, at which time the Parties and the Hearing Officer may discuss any issues arising due to the granting of the requested extension.
