- 1) What compliance issues still exist? Which issues have been settled?
- 2) What counts of the 2009 amended complaint impede the resolution of the issues in dispute?
- 3) Has a proposal been made to resolve the issues in dispute? If so, who made the proposal and when is a response to the proposal expected?
- 4) What are the dates of the most recent three discussions when the parties met to discuss the settlement?
- 5) Is a future meeting scheduled?
- 6) Can you provide an estimate of when settlement may be reached, or explain the reasons for any delay?
- 7) Provide a reasonable schedule for discovery and dispositive motions that both parties can agree on that leads to a hearing date for this action in 2016. If the Board finds that the schedule is acceptable, it may adopt the schedule with the aim of resolving this action in 2016.
