**HEARING OFFICER ORDER**

On December 2, 2015, the parties participated in a telephone status conference with the hearing officer. All parties appear to have reached settlement agreements on compliance, but disagree as to whether the penalty demand is resolved. The Illinois Environmental Protection Agency has agreed to stipulations for some of the parties, and the agreements are under review by management at the Attorney General's Office. Upon approval, the proposed settlement agreements will be sent to respondents. Some of the respondents' stipulations have required updates, and are still under review at IEPA.

The parties are directed to participate in a telephone status conference with the hearing officer at 10:15 a.m. on December 21, 2015. A conference call-in number will be circulated.
