#### MOTION FOR AN EXTENSION OF TIME TO FILE THE AGENCY'S RECOMMENDATION

In support thereof, the Illinois EPA states as follows:

1. On July 21, 2015, the Petitioner filed its Variance Petition from the chloride water quality standards recently adopted in R08-09.

2. Pursuant to the hearing officer Order issued on September 1, 2015, the Agency is to file its recommendation with respect to the Variance Petition on December 3, 2015.

3. Illinois EPA is still reviewing the Variance Petition and is in continuing discussions with the Petitioner and USEPA. Illinois EPA would like to complete those discussions before filing a recommendation in this matter.

4. The Agency has reached out to the Petitioner and they have advised Illinois EPA that they have no objection to the requested extension of time to file the Agency's

recommendation. The Petitioner has also indicated that it is willing to file additional waivers of the statutory decision deadline as needed to accommodate the requested extension of time.

5. The requested extension should not prejudice or harm any interested party.

6. Therefore, the Agency is asking that the Board grant its Motion for Extension

Time and extend the deadline for filing its recommendation until March 1, 2016.
