#### AFFIDAVIT

I, Michelle M. Ryan, being first duly sworn upon oath, depose and state as follows:

1. I am employed by the Illinois Environmental Protection Agency ("Illinois EPA"), as Assistant Counsel for the Bureau of Land.

2. As part of my duties, I am responsible for the preparation of Administrative Citations issued by the Illinois EPA and the negotiation and litigation of appeals filed pursuant to such Administrative Citations. As part of my job experience, I have also submitted travel vouchers for reimbursement.

3. I have reviewed the Illinois EPA Division of Legal Counsel File 50-11-AC, which relates to AC 11-22, *Illinois EPA v. Kyle Pritchett*, for the purpose of determining the costs expended by Illinois EPA.

4. I was the Illinois EPA attorney assigned to handle the hearing for AC 11-22, which was held in Mt. Carmel. I was required to travel from Springfield to Mt. Carmel and back. The Illinois Department of Transportation map of the State of Illinois indicates that the distance between Springfield and Mt. Carmel is 214 miles. Because I attended another hearing in Mt. Carmel on the same date, I am only seeking reimbursement for mileage for the return trip. Based on my own job experience, I am aware that the approved mileage reimbursement rate in September 2015 was \$.565 per mile.

5. As the attorney currently assigned to handle Administrative Citations, I am aware that Illinois EPA incurs costs for copying documents, preparation of documents for mailing and

service, and certified and first class mailings. Based upon my review of File 50-11-AC, I estimate that these costs expended by Illinois EPA on this Administrative Citation through the hearing date approximate \$35.00.
