#### JURISDICTION

This Administrative Citation is issued pursuant to authority vested in the Illinois Environmental Protection Agency by 415 ILCS 5/1 *et. seq.* (2004), specifically 415 ILCS 5/31.1.

#### **FACTS**

- 1. The Respondent, Larry K. Wilson, is the present owner of a facility located in the County of Ogle, State of Illinois.
- 2. The facility, located at 4225 W. IL Rte. 64, Mt. Morris, IL, is an open dump, operating without an Illinois Environmental Protection Agency Operating Permit, and designated with the Site Code #1418155009. The facility is known to the Agency as Wilson, Larry.
- 3. That Respondent, Larry K. Wilson, has controlled and/or operated the facility at all relevant times hereto.
- 4. That on November 10, 2015, the Ogle County Solid Waste Management

  Department received a phone message and email from Mt. Morris Fire Chief,

  Robert Hough IV, that a new fire had been started in the foundation of the

  demolished barn, and that building debris was being burned.

5. That on November 12, 2015, Paul Cooney, Solid Waste Management Specialist, and Stephen J. Rypkema, Director, Ogle Co. Solid Waste Mgmt. Dept. (OCSWMD), inspected the facility after acquiring and executing an Administrative Search Warrant.

#### **VIOLATIONS**

On the basis of direct observation by Paul Cooney and Stephen Rypkema, it was determined that the Respondent has caused or allowed open dumping and open burning at the above described facility in a manner that has violated the Illinois Environmental Protection Act (hereinafter, the "ACT") as follows:

- 1. The Respondent has caused or allowed littering in violation of 415 ILCS 5/21(p)(1) on or about November 10, 2015.
- 2. The Respondent has caused or allowed open burning in violation of 415 ILCS 5/21(p)(3) on or about November 10, 2015.
- 3. The Respondent has caused or allowed the deposition of general construction or demolition debris or clean construction or demolition debris in violation of 415 ILCS 5/21(p)(7) on or about November 10, 2015.

#### CIVIL PENALTY

In accordance with 415 ILCS 5/42 (b)(4), the Respondent is subject to a civil penalty of \$1,500.00 for each violation specified above. This is a total of \$4,500.00 for this Administrative Citation. Additionally, should the Respondent elect to petition the Illinois Pollution Control Board under the review process described below, after an adjudicatory hearing, the Respondent

shall be assessed the hearing costs incurred by the Pollution Control Board and Ogle County.

The hearing cost would be in addition to the fine.

If you acknowledge the violations cited herein above, the civil penalty shall be due and payable no later than 35 days from the date of service hereof. If you do not petition the Pollution Control Board for review of the Administrative Citation within 35 days of service of the Administrative Citation, or contest the Citation, any judgment that may be rendered against you shall specify the due date of the civil fine and any additional costs assessed against you.

When payment is made, checks shall be made payable in equal amounts (\$2,250, or 50% of the total penalty each) to:

- (1) Illinois Environmental Protection Trust Fund and mailed to the attention of Fiscal Services, Illinois Protection Agency, 1021 North Grand Avenue East, P.O. Box 19276, Springfield, Illinois 62794-9276.
- (2) Ogle County Solid Waste Fund, Ogle County Treasurer, P.O. Box 40, Oregon, Illinois 61061.

If any civil penalty is not paid within the prescribed time, the law allows for the accumulation and payment of interest on the remaining unpaid balance. If any civil penalty is not paid when due, the Office of the State's Attorney shall be requested to initiate proceedings in Circuit Court to collect the penalty. In addition to the civil penalty, hearing costs, and interest, if any, the Ogle County State's Attorney may seek to recover their costs of litigation.

#### PROCEDURE FOR CONTESTING ADMINISTRATIVE CITATION

You have the right to contest this Citation, pursuant to 415 ILCS 5/31.1. If you elect to contest this Citation, you must file a Petition For Review with the Clerk of the Illinois Pollution Control Board. A copy of the Petition For Review shall be filed with the Ogle County State's Attorney. Your Petition For Review must be filed within 35 days of the date of service of the present citation on you. If you fail to file your Petition, a Default Order against you will entered by the Pollution Control Board.

#### General Remarks

The Ogle County Solid Waste Management Department (OCSWMD) received an email from Fire Chief Robert Hough of the Mt. Morris Fire Department (MMFD) on November 10, 2015 at 2:52 p.m., indicating that a citizen notified the MMFD that there was building debris being burned inside the foundation of the barn which Mr. Wilson had been demolishing. This email is presented in Attachment A. This email was the most recent in a lengthy correspondence between the OCSWMD and MMFD regarding the on-going dumping and burning of demolition debris on property owned by Mr. Wilson at 4225 W. IL RTE 64 in Mt. Morris.

On November 12, 2015, Paul Cooney asked the Ogle County State's Attorney for a second Administrative Search Warrant to complete an inspection of this property. The warrant was obtained in the afternoon of that day. A search warrant for this inspection was requested because on October 28, 2015, S. Rypkema and P. Cooney were told by Mr. Wilson to leave the property and not to return without a warrant. OCSWMD completed prior inspections on October 28, 2015 and October 29, 2015. Since these inspections, most of the debris from a barn which had been demolished had been burned. The violations occurring on this property are the basis for three Administrative Citations (AC) currently being brought by the OCSWMD against Mr. Wilson.

We returned to the site and arrived at 2:30 p.m. We had requested, and received, a Sheriff's Deputy to accompany us on the inspection. Deputy Pennington from the Ogle County Sheriff's Department met us at the site for the inspection. In addition to Deputy Pennington, Chief White of the Mount Morris Police Department was present and another Sheriff's Deputy also arrived during our inspection.

Deputy Pennington located Mr. Wilson, who was in a large garage upon our arrival. The warrant was presented to Mr. Wilson and Steve asked him about the most recent complaint of burning of debris in the foundation of the demolished barn. Mr. Wilson said that they were burning wood in a burn barrel. Steve asked Mr. Wilson if he would answer any more questions and he said that he would not be answering any more of our questions. Steve told Mr. Wilson that each burning

incident that is documented has the potential for additional fines. Mr. Wilson told us to complete our inspection and did not say anything else.

We began our inspection in the area where the barn had been demolished. The area had, for the most part, been leveled off with soil, and several chunks of broken concrete and other debris remain in the area. The western wall of the basement, and what appeared to be a stairwell, was partially visible. In this area there was soot on cinder blocks, burnt wood debris, and ash which was still smoldering. It appears that demolition debris was burned in this area. There also was metal tubing and other waste protruding from the partially buried foundation, indicating that there was most likely waste buried in this area as well. Photos #1-10.

We then drove over to the large ash pile at the southern end of the property where the material from the demolished barn had been burned for the last week or so. The ash pile was still hot and smoldering. There was very little recognizable waste in the ash. Most of the wood that had been dumped in this location, documented in our October 28 & 29, 2015 inspections, had been burned. The ash pile was roughly 30 feet by 15 feet and at some points about 6 feet tall. Waste present in the ash included plastic, mattress springs, nails, electrical conduit and box, hinges, fiberglass, shingles, lumber, paneling, metal brackets, broken concrete, bricks, and other waste. There also was a pallet laying on the ash pile. Photos #11-31.

We then drove over to a pile of broken concrete which appeared to be the remnants of the barn foundation. Material had been added to this pile since our October 29, 2015 inspection. Several pieces of this material had protruding rebar and some had lumber attached as well. There were also two metal tire rims in the pile. This material at the time of inspection, appeared to be general construction and demolition debris, and not clean fill material. To the west of the broken concrete there were several large wooden utility poles. Photos #32-40.

We left the site at 2:57 p.m.

#### Alleged Violations

- 1. Pursuant to Section 9(a) of the Act, no person shall cause or threaten or allow the discharge or emission of any contaminant into the environment in any State so as to cause or tend to cause air pollution in Illinois, either alone or in combination with contaminants from other sources, or so as to violate regulations or standards adopted by the Board under this Act.
  - A violation of Section 9(a) of the [Illinois] Environmental Protection Act (415 ILCS 5/9(a)) is alleged for the following reason: On November 10, 2015, Respondent caused and/or allowed air pollution by the burning of demolition waste from a barn which was demolished on this property. Evidence of this fire, still smoldering, is shown in the inspection photos.
- 2. Pursuant to Section 9(c) of the Act, in relevant part, no person shall cause or allow the open burning of refuse, conduct any salvage operation by open burning, or cause or allow the burning

of any refuse in any chamber not specifically designed for the purpose and approved by the Agency pursuant to regulations adopted by the Board under this Act.

A violation of Section 9(c) of the [Illinois] Environmental Protection Act (415 ILCS 5/9(c)) is alleged for the following reason: On November 10, 2015, Respondent caused or allowed the open burning of refuse and demolition waste from a barn which was demolished on this property. Evidence of this fire, still smoldering, is shown in the inspection photos.

- 3. Pursuant to Section 21(a) of the Act, no person shall cause or allow the open dumping of any waste.
  - A violation of Section 21(a) of the [Illinois] Environmental Protection Act (415 ILCS 5/21(a)) is alleged for the following reason: Respondent has caused and/or allowed the open dumping of demolition debris and other waste at various locations on this property.
- 4. Pursuant to Section 21(d)(1) of the Act, in relevant part, no person shall conduct any waste-storage, waste-treatment, or waste-disposal operation without a permit granted by the Agency or in violation of any conditions imposed by such permit, including periodic reports and full access to adequate records and the inspection of facilities, as may be necessary to assure compliance with this Act and with regulations and standards adopted thereunder.
  - A violation of Section 21(d)(1) of the [Illinois] Environmental Protection Act (415 ILCS 5/21(d)(1)) is alleged for the following reason: Respondent is conducting a waste storage and disposal operation at this property without an Agency permit.
- 5. Pursuant to Section 21(d)(2) of the Act, no person shall conduct any waste-storage, waste-treatment, or waste-disposal operation in violation of any regulations or standards adopted by the Board under this Act.
  - A violation of Section 21(d)(2) of the [Illinois] Environmental Protection Act (415 ILCS 5/21(d)(2)) is alleged for the following reason: Respondent was conducting a waste storage and disposal operation on this property in violation of standards set forth in the Act.
- 6. Pursuant to Section 21(e) of the Act, no person shall dispose, treat, store or abandon any waste, or transport any waste into this State for disposal, treatment, storage or abandonment, except at a site or facility which meets the requirements of this Act and of regulations and standards thereunder.
  - A violation of Section 21(e) of the [Illinois] Environmental Protection Act (415 ILCS 5/21(e)) is alleged for the following reason: Respondent has used the property as an unpermitted waste storage and disposal site, and as such, this site does not meet the standards set forth in the Act.
- 7. Pursuant to Section 21(p)(1),(3)&(7) of the [Illinois] Environmental Protection Act (415 ILCS

5/21(p)(1),(3)&(7)), no person shall, in violation of subdivision (a) of this Section[21], cause or allow the open dumping of any waste in a manner which results in

- (1) litter;
- (3) open burning;
- (7) deposition of:
  - (i) general construction or demolition debris as defined in Section 3.160(a) of this Act; or
  - (ii) clean construction or demolition debris as defined in Section 3.160(b) of this Act.


The prohibitions specified in this subsection (p) shall be enforceable by the Agency either by administrative citation under Section 31.1 of this Act or as otherwise provided by this Act. The specific prohibitions in this subsection do not limit the power of the Board to establish regulations or standards applicable to open dumping.

Violations of Section 21(p)(1), (3) & (7) of the [Illinois] Environmental Protection Act (415 ILCS 5/21(p)(1), (3) & (7)) are alleged for the following reasons: Respondent has caused and/or allowed litter, open burning and deposition of general construction and demolition debris upon this property by openly dumping and burning of waste generated as a result of the demolition of a barn on the property.



- #1 Immediately cease all open dumping of waste.
- #2 Immediately cease all open burning of waste.
- #3 Do not bury any waste.
- H4 By January 25, 2016, remove and haul all remaining waste to an Illinois permitted landfill or transfer station. Waste includes any remaining debris from the demolition of the barn, including wood, roofing materials, doors, windows, fasteners, electrical components, ash from the previous open burning of demolition debris, and scrap metal. Scrap metal not disposed of at a permitted landfill can be taken to a scrap metal facility or recycling center.
- By January 25, 2016, all buried waste from this site must be uncovered and taken for disposal to an Illinois permitted landfill or transfer station. Contaminated soil (soil mixed with waste) must also be taken to an Illinois permitted landfill or transfer station for disposal.

- #6 Areas where buried waste has been removed may not be refilled until inspected by and approval given by the Ogle County Solid Waste Management Department (OCSWMD).
- #7 Clean concrete may be used as fill material provided the material meets the standard for clean construction and demolition debris used as fill material in the Act (Sec 3.160 (b)).
