<u>CITIZENS GROUPS' MOTION FOR EXTENSION OF TIME TO RESPOND TO</u> <u>MIDWEST GENERATION, LLC'S MOTION TO STRIKE THE DISCUSSION OF THE</u> <u>FEDERAL CCR RULES</u>

Pursuant to Board Rule 101.500(d), Sierra Club, Environmental Law & Policy Center

("ELPC"), Prairie Rivers Network, and Citizens Against Ruining the Environment ("CARE")

(collectively "Citizens Groups"), by and through their counsel, respectfully request a brief

extension of one week, until January 12, 2016, to respond to Midwest Generation, LLC's

("Midwest Gen") Motion to Strike The Discussion of the Federal CCR Rules ("Motion to

Strike"). In support of this request, Citizens Groups state as follows:

1. Midwest Gen filed its Motion to Strike on December 22, 2015.

2. Board Rule 101.500(d) provides that responses to motions are due within 14 days after the motion is filed. Fourteen days after December 22, 2015 is January 5, 2016.

3. Due to longstanding vacation plans during the upcoming Christmas and New Year holidays, it would be very challenging for Citizens Groups to complete their response to the Motion to Strike within the fourteen day timeframe provided by Board Rule 101.500(d).

4. A one-week delay in Citizens Groups' response to Midwest Gen's Motion to Strike would not prejudice any party because the dispute at issue in the motion can be resolved well within the expert discovery period that, per the September 30, 2015 scheduling order, extends until April 1, 2016.

WHEREFORE, Citizens Groups respectfully request an extension of time allowing them until January 12, 2016, to respond to Midwest Gen's Motion to Strike.
