
HEARING OFFICER ORDER

On February 4, 2016, all parties participated in a telephonic status conference with the hearing officer. The parties were informed that the Board has accepted the above-captioned matter. The parties were further informed that the record is due to be filed on or before February 25, 2016, and that the statutory decision date is May 5, 2016.

Respondent Waste Management of Illinois, Inc., stated that it will file an additional waiver of the statutory decision date to and including August 18, 2016. Respondent stated that it will file a motion for an extension of time to file the record. Finally, the parties were directed to submit a discovery schedule on or before February 19, 2016.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on March 9, 2016, at 1:30 p.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.
