<u>RECOMMENDATION OF THE ILLINOIS</u> <u>ENVIRONMENTAL PROTECTION AGENCY</u>

The Illinois Environmental Protection Agency (Illinois EPA) hereby files its

Recommendation pursuant to Section 125.204(a) of the regulations of the Illinois

Pollution Control Board (the Board), 35 Ill. Adm. Code 125.204(a).

1. On June 29, 2015, the Illinois EPA received a request from Jason Bielema (log

number TC-16-15, Exhibit A) for an Illinois EPA recommendation regarding the

tax certification of water pollution control facilities pursuant to Section

125.204(a) of the Board's regulations, 35 III. Adm. Code 125.204(a).

2. The facility's address is:

Jason Bielema 15415 US Hwy 52 Carroll County, Illinois

3. The proposed water pollution control facilities in this request are located at Section 10, T24N, R4E of the 4th P.M. in Carroll County, at the above street address and consist of the following:

> Livestock waste handling facilities consisting of one concretemanure-pit (approximately 100 ft. x 193 ft. x 8 ft. deep) with slotted floors over the pit to collect livestock waste. The pit has eight concrete pump out slots (each approximately 3 ft x 3 ft x 8 ft deep) to remove manure from the pits.

- 4 These livestock waste management facilities are used to collect, transport and/or store livestock wastes prior to cropland application, and are further described in Exhibit A.
- 5. Section 11-10 of the Property Tax Code, 35 ILCS 200/11-10 (2014), and Section 125.200(a)(1) of the Board's regulations, 35 III. Adm. Code 125.200(a)(1), define pollution control facilities as:

[A]ny system, method, construction, device or appliance appurtenant thereto or any portion of any building or equipment, that is designed, constructed, installed or operated for the primary purpose of: eliminating, preventing, or reducing air or water pollution, as the terms "air pollution" and "water pollution" are defined in the Act; or treating, pretreating, modifying or disposing of any potential solid, liquid or gaseous pollutant which if released without treatment, pretreatment, modification or disposal might be harmful, detrimental or offensive to human, plant or animal life, or to property.

- 6. If it is found that the claimed facility or relevant portion thereof is a pollution control facility as defined in Section 125.200(a)(1) of the Board's regulations, 35 III. Adm. Code 125.200(a)(1), the Board has the authority to enter a finding and issue a certificate to that effect, pursuant to Section 11-20 of the Property Tax Code, 35 ILCS 200/11-20 (2014) and Section 125.216 of the Board's regulations, 35 Ill. Adm. Code 125.216.
- Pursuant to Section 125.204(a) of the Board's regulations, 35 Ill. Adm. Code
 125.204(a), if the Illinois EPA receives a tax certification application it must file a recommendation on the application with the Board.
- 8. Based on the information in the application and the purpose of the facilities, it isthe Illinois EPA's engineering judgment that the described facilities may be

considered pollution control facilities, with the primary purpose of eliminating, preventing, or reducing water pollution, or as otherwise provided in Section 125.200(a)(1) of the Board's regulations, 35 Ill. Adm. Code 125.200(a)(1), and are eligible for tax certification from the Board.

WHEREFORE, the Illinois EPA recommends that the Board issue the requested tax certification.



The Bureau of Water received a request on June 29, 2015 from Bielema Farms for an Illinois EPA recommendation regarding the tax certification of water pollution control facilities pursuant to 35 Ill. Adm. Code 125.204. We offer the following recommendation.

The water pollution control facilities in this request include the following:

Bielema Farms 15415 US Hwy 52 Mount Carroll, IL 61053

Section 10, T24N, R4E of the 4th PM in Carroll County

Livestock waste management facilities consist of one concrete manure pit (approximately 100 ft. x 193 ft. x 8 ft. deep), eight concrete pump outs (each approximately 3 ft. x 3 ft. x 8 ft. deep), and slotted floors over the pit to collect livestock waste. These livestock waste management facilities are used to collect, transport, and/or store livestock waste prior to cropland application.

These facilities are further described in the enclosed applications and supporting documents.

Based on the information included in this submittal, it is our engineering judgment that the above proposed facilities may be considered "Pollution Control Facilities" under 35 IAC 125.200(a), with the primary purpose of eliminating, preventing, or reducing water pollution, or as otherwise provided in this section, and therefore eligible for tax certification from the Illinois Pollution Control Board. The Bureau of Water therefore recommends that the Board issue the requested tax certification for these facilities.

Physical Description of Pollution Control Devices:


This facility consists of one concrete manure pit (100 ft. x 193 ft. x 8 ft. deep), slotted floors to collect swine waste, and eight concrete pump outs (each 3 ft. x 3 ft. x 8 ft. deep). The manure is pumped out of the pits and applied to the fields as crop fertilizer.

8/14/2015 - I spoke with Jason Bielema who confirmed that he only wants the manure pit, slotted floors, and pumps outs certified as pollution control devices and not the entire building. Jason confirmed that he is the owner of the facility and the manure pit was installed in November of 2013. Jason confirmed that manure pit is concrete. Jason also confirmed that there are eight concrete pump outs that each measure approximately 3 ft. x 3 ft. x 8 ft. deep.

The primary purpose for these structures is to contain swine manure thereby preventing contaminated water runoff.

Recommended Action: Permit the above mentioned structures.





The manure spreader is used to loject the waste into the ground through a no-till toolbar, preventing runoff and maximizing the fertilizer value of manure.
