RESPONDENT WILL COUNTY'S
MOTION FOR EXTENSION OF TIME TO FILE RECORD

NOW COMES Respondent, WILL COUNTY, ILLINOIS, by and through its attorneys, HINSHAW & CULBERTSON LLP, and for its Motion for Extension of Time to File Record, states as follows:

1. On July 10, 2015, Waste Management of Illinois, Inc. (hereinafter referred to as "WMI") filed its Application for Local Siting Approval for the expansion of the Laraway Recycling and Disposal Facility (hereinafter the "Application") with the Will County Clerk.
2. Three public hearings were held on the Application, beginning October 14, 2015, continuing to October 21, 2015, and ending on October 23, 2015.
3. After a review of the entire record, the Will County Pollution Control Facility Committee met in open session on December 10, 2015, and recommended that the site location approval be granted for expansion of this pollution control facility subject to certain special conditions recommended by the Committee.
4. On December 17, 2015, the Will County Board adopted a Resolution finding that the Pollution Control Facility Committee's decision and recommendation should be adopted and WMI's Application was granted.

5. On January 19, 2016, Petitioner, Environmental Recycling and Disposal Services, Inc., filed the present appeal with the Illinois Pollution Control Board asking the Board to review the December 17, 2015 decision of the Will County Board.

6. On February 4, 2016, the Hearing Officer issued an Order informing the parties that the record is due to be filed on or before February 25, 2016.

7. The record in this case is voluminous and Will County is in need of additional time within which to file said record. Will County informed the Hearing Officer during the February 4, 2016 telephonic status that it will be filing the present Motion for Extension of Time to File Record. No objections were noted to that request.

8. Will County requests an extension of time to file the record to March 11, 2016. This extension is not sought to delay these proceedings and no party will be prejudiced by the granting of this extension.

WHEREFORE, Respondent, WILL COUNTY, respectfully requests that this Board grant its Motion for Extension of Time to File Record, and allow Respondent an extension to file the record on or before March 11, 2016, plus grant Respondent such other and further relief as this Board deems just and proper.
