
HEARING OFFICER ORDER

On February 18, 2016, the parties informed the hearing officer that they have reached an agreement on the proposed NPDES permit and that it has been forwarded to the United States Environmental Protection Agency (USEPA) for its review. The parties are cautiously optimistic that the USEPA will approve the permit.

The petitioners stated that they will file additional and respective waivers to at least July 7, 2016.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on March 24, 2016, at 10:00 a.m. Please note the change of date and time. The telephonic status conference must be initiated by the petitioners, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.
