MCCAMBRIDGE: This is the 2 hearing in Board docket R16-2 in the matter of 3 National Ambient Air Quality Standards US EPA 4 Amendments January 1st of 2015 through June 30th, 5 2015; August 26th, 2015; October 26th, 2015; 6 November 19th, 2015; and December 18th, 2015. 7 This hearing is being held to 8 satisfy the Clean Air Act requirement for a public 9 hearing before the state would submit a SIP 10 submittal and the Board fully anticipates that the Agency will submit a SIP revision to embrace the 11 12 amendments once they're adopted. 13 I'm the Hearing Officer. Μv 14 name is Mike McCambridge. Sitting to my left is the attending Board Member Jennifer Burke. 15 16 Could you identify personnel for 17 the Agency? 18 MR. MATOESIAN: Yes, Charles 19 Matoesian appearing for the Illinois Environmental 20 Protection Agency and with me today I have 21 Yoginder Mahajan who is an environmental 22 protection engineer with the Agency and he is here 23 to answer any questions you may have for the 24 public.

Page 4 1 MR. MCCAMBRIDGE: Okay. We do have 2 a couple members of Board staff in the room as we 3 said, Mark Powell and one of our interns. 4 MR. MATHIS: Jeff Mathis. 5 MR. MCCAMBRIDGE: Now, the Board 6 adopted a proposal for public comment on this on 7 December 17th. The notice of proposed amendments 8 appeared in the January 4th Illinois Register. 9 The public comment period based on that notice 10 expires today February 18th, 2016. 11 Since the proposal for public 12 comment, on December 18th, 2015, US EPA released 13 an updated version of the list of designated --14 what is it? Designated -- I call it the list of 15 designated methods. It's a reference and 16 equivalent methods, I think, but the final opinion 17 and order will be changed to refer -- reference 18 that document rather than the June 18th, 2015, 19 version of the list and the August 26th, October 20 26th and November 19th methods/approvals from the 21 Federal Register. 22 Now, does the Agency have 23 anything to put on record? 24 MR. MATOESIAN: No, we don't.

Page 5 1 MR. MCCAMBRIDGE: Ms. Burke, do you 2 have anything? 3 MS. BURKE: No, I don't. 4 MR. MCCAMBRIDGE: Seeing that nobody 5 present has anything to add to the record, I 6 anticipate that this will be before the Board at 7 the March 3rd meeting. It has a due date, if I'm 8 not mistaken -- what was it? March 13th. I can't 9 recall off the top. So we will be moving rather 10 rapidly to get this on file with the Secretary of State and make the amendments effective. 11 12 MR. MATOESIAN: I should say one little slight point. We did not know about the 13 14 December change. So we have not reviewed that at 15 present. That's the only comment we would have. 16 MR. MCCAMBRIDGE: Okay. If you 17 wish, I can send you a -- digitally send you a 18 copy of the December 18th version of that list of 19 methods. 20 MR. MATOESIAN: Okay. That would be 21 great. 22 MR. MCCAMBRIDGE: Okay. I will do 23 that immediately after I leave the room here. 24 MR. MATOESIAN: Thank you.
