

HEARING OFFICER ORDER

On March 17, 2016, a telephonic status conference was held. The petitioner was unavailable due to a scheduling conflict. The Illinois Protection Agency's (Agency) counsel stated that public notice has ended and is reviewing some comments submitted by the petitioner. The Agency is presently reviewing the comments and the parties remain optimistic that the Agency will issue a permit.
