
**AMENDED HEARING OFFICER ORDER**

On March 31, 2016, all parties participated in a telephonic status conference with the hearing officer. Kincaid Generation LLC. (Kincaid) stated that since the last status conference, the revised permit proceeded to a 15-day notice and received some comments. Kincaid is now reviewing the comments. The revised permit will then proceed to a 30-day notice.

Kincaid stated that it will file an additional waiver of the statutory decision deadline to and including October 6, 2016. By agreement, the administrative record is now due to be filed on or before July 1, 2016.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on June 1, 2016, at 11:30 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.
