#### JOINT MOTION FOR SUBSTITUTION OF PETITIONER

Petitioner, NRG WHOLESALE GENERATION LP ("NRG") and proposed petitioner, SHELBY COUNTY ENERGY CENTER, LLC ("SCEC"), move this Board to allow the substitution of SCEC as the petitioner, in place of NRG. In support of this motion, NRG and SCEC state as follows:

- 1. NRG filed the original petition for review of the CAAPP Permit for Shelby County Generating Station on October 29, 2014, requesting review of a permit issued to NRG on September 26, 2014 (I.D. No. 173801AAA), for the operation of the Shelby County Generating Station.
- 2. On March 1, 2016, Shelby County Generating Station was acquired by proposed petitioner SCEC, an affiliate of Rockland Capital, LLC, at which time ownership and operation of the station by NRG ceased.
- 3. On March 15, 2016, SCEC requested an administrative amendment to CAAPP Permit No. 02020093 from the Illinois Environmental Protection Agency ("IEPA") to transfer the permit to SCEC. IEPA acknowledged the name and ownership change on March 23, 2016. *See* Ex. A (March 23, 2016 IEPA Acknowledgment of Name/Ownership Change CAAPP Permit), attached.

WHEREFORE, petitioner, NRG WHOLESALE GENERATION LP and proposed petitioner, SHELBY COUNTY ENERGY CENTER, LLC, respectfully request that the Board dismiss NRG WHOLESALE GENERATION LP as a party in this matter and substitute as the petitioner, SHELBY COUNTY ENERGY CENTER, LLC.
