
HEARING OFFICER ORDER

On April 27, 2016, a telephonic status conference was held. The respondent did not appear due to a scheduling conflict. The complainant stated that the stipulation and proposal for settlement (stipulation) is still being circulated for review and signatures. The parties are hopeful that the stipulation will be filed within the next thirty days.

To that end, respondent's answer or other responsive pleading is now due to be filed on or before June 17, 2016.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on June 1, 2016, at 10:30 a.m. The telephonic conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing. If, however, a stipulation is filed prior to the next status conference, the conference will be cancelled without further notice.

IT IS SO ORDERED.




