
HEARING OFFICER ORDER

On April 28, 2016, all parties participated in a telephonic status conference with the hearing officer. Discussions centered on the April 7, 2016, Board order. Petitioners stated that they were contemplating filing a written motion for clarification of the Board order. By agreement, petitioners must file the motion for clarification, if any, on or before May 9, 2016.

At the next status conference, hearing dates will be discussed. At that time, it is anticipated that respondent Midwest Generation, LLC., will file an additional waiver of the statutory decision deadline to allow a reasonable time for the hearing and post-hearing briefs.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on May 12, 2016, at 12:30 a.m. The telephonic conference must be initiated by the petitioners, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.
