
HEARING OFFICER ORDER

On May 19, 2016, a telephonic status conference was held with the hearing officer. Respondent did not appear. The complainant stated again that it appears the parties have reached a resolve in this matter and will be drafting a stipulation and proposal for settlement (stipulation). Included in the stipulation will be a supplemental environmental project (SEP). The SEP, however, will not be able to be implemented until next mulching season.

To that end, respondent's answer or other pleading is now due to be filed on or before August 5, 2016.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on July 21, 2016, at 9:30 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing. If, however, a stipulation is filed prior to the next status conference, the conference will be cancelled without further order.

IT IS SO ORDERED.




