WAIVER OF STATUTORY DECISION DEADLINE

On January 27, 2014, the Petitioners, Prairie Rivers Network, Natural Resources Defense Counsel, Sierra Club, Environmental Law & Policy Center, Friends of Chicago River and Gulf Restoration Network, filed with the Illinois Pollution Control Board ("Board") a Third-party Petition for NPDES Permit Appeal On December 18, 2014, the Board adopted an order and opinion denying summary judgment for Petitioners and granting summary judgment for the Respondents, Illinois Environmental Protection Agency and Metropolitan Water Reclamation District of Greater Chicago Following an appeal of that opinion and order, the Illinois Appellate Court issued a mandate on May 4, 2016 reversing the Board's decision and remanding the case back to the Board for further proceedings

The Metropolitan Water Reclamation District of Greater Chicago hereby waives the 120-day statutory decision deadline for the case on remand as provided for in 35 Ill Adm Code 101 308. The District's waiver is an open waiver as specifically provided for in Section 101 308(c)(1).
