HEARING OFFICER ORDER


On June 30, 2016, all parties participated in a telephonic status conference with the hearing officer. The complainant stated that it has been difficult to arrange a meeting with the Illinois Environmental Protection Agency and respondent City of Morris but that a July 27, 2016, is now planned. Discussions will center on technical remedy for the closing of the landfill.

The complainant is again hopeful that by the next status conference it will know whether they will dismiss the above-captioned matter and proceed to circuit court.

The parties are encouraged to consent to receive e-mail service of my orders. Consent may be e-mailed and need only include a name, e-mail address and reference this docket number.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on August 24, 2016, at 11:30 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


