HEARING OFFICER ORDER


On June 30, 2016, all parties participated in a telephonic status conference with the hearing officer. It was again noted that petitioner's former counsel withdrew her appearance on May 24, 2016. Mr. Anderson a non-attorney and part owner of Distressed Properties, Inc., appeared and was again informed that his company is required to be represented by a licensed attorney pursuant to Section 101.400(a)(2) of the Board's procedural rules. Mr. Anderson stated that he has discussed this issue with his partner and that they have agreed not to retain an attorney.

Counsel for the respondent stated that he will draft a motion to dismiss based on the aforesaid and will forward it to Mr. Anderson for review. Mr. Anderson indicated that he may or may not object to the motion. Counsel for respondent stated that he will file the motion on July 1, 2016.

The parties are encouraged to consent to receive e-mail service of my orders. Consent may be e-mailed and need only contain a name, e-mail address and reference this docket number.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on July 19, 2016, at 1:00 p.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.
