MOTION TO DISMISS

NOW COMES the Respondent, ILLINOIS ENVIRONMENTAL PROTECTION AGENCY ("Illinois EPA"), by and through its attorney, Special Assistant Attorney General Scott B. Sievers, and for its motion to dismiss the Petitioner's action states the following:

1. The Supreme Court of Illinois has held that "[a] corporation must be represented by counsel in legal proceedings." *Downtown Disposal Services, Inc. v. City of Chicago*, 2012 IL 112040, ¶ 17.

2. Section 101.400 of the Pollution Control Board's procedural rules provides that, while individuals may appear on their own behalf before the Board, a corporation "must appear through an attorney-at-law licensed and registered to practice law." 35 Ill. Adm. Code 101.400(a)(2); *see also* 35 Ill. Adm. Code 101.202 (Board definition of "person" includes both "individual" and "corporation"). A corporation's failure to appear before the Board through an attorney may be grounds for dismissal of a petition. *See In the Matter of: Petition of Midway RACS, LLC for Adjusted Standard from 35 Ill. Adm Code 218.586*, at 2.

3. On May 24, 2016, attorney Elizabeth S. Harvey and her law firm of Swanson, Martin & Bell, LLP withdrew their appearance before this Board as counsel for the Petitioner.

4. On June 1, 2016, Petitioner's part owner, James Anderson, participated in a telephonic status conference with the Board hearing officer, at which time Mr. Anderson, a non-attorney, was informed that the Petitioner, being a corporation, was required to be represented before this Board by a licensed attorney. Mr. Anderson said he would discuss the issue with his business partner prior to the next status conference.

5. On June 16, 2016, the hearing officer held another telephonic status conference and reiterated that the Petitioner must be represented before this Board by a licensed attorney. Mr. Anderson said he would continue to discuss the issue with his business partner.

6. On June 30, 2016, the hearing officer held another telephone status conference and restated that this Board's rules required the Petitioner to be represented through a licensed attorney. Mr. Anderson indicated that no attorney had been retained on behalf of the Petitioner.

7. The Petitioner is a corporation, and Illinois law and this Board's rules require that it appear through a licensed attorney. The hearing officer has repeatedly so informed Mr. Anderson. Only Mr. Anderson, a non-attorney, has participated in this action on behalf of the Petitioner since its prior attorney and her law firm withdrew from this case. As no duly licensed Illinois attorney has entered his or her appearance on behalf of the Petitioner, and as the Petitioner is required as a corporation to appear before the Board through an attorney and has failed to do so, the Respondent moves for dismissal of the instant action with prejudice.

AGENCY, prays that this honorable Board grant the Respondent's Motion to Dismiss and dismiss the instant action with prejudice.
