HEARING OFFICER ORDER


On June 30, 2016, all parties participated in a telephonic status conference with the hearing officer. Petitioner stated that it anticipates closing a deal on or about July 8, 2016, that would involve a sale of the Aurora facility as well as a sale of the stock in the related appeal PCB 15-86 of NRG Rockford LLC and NRG Rockford II LLC. After that sale, petitioner anticipates that the new owner of the Aurora facility will file appropriate papers requesting the Board to substitute parties in this proceeding.

The petitioner stated that it will file an additional waiver of the statutory decision deadline to and including December 15, 2016.

The parties are encouraged to consent to receive e-mail service of my orders. Consent may be e-mailed and need only include name, e-mail address and reference to this docket number.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on September 8, 2016, at 11:15 a.m. The telephonic conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing


